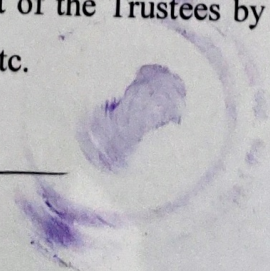

(d) To accept grants, donations, presents, gifts and offerings from the parents of the students and other persons and to deal with the same for the purposes of the Trust.

(g) To do all other acts and things as may be necessary or conducive to the attainment of the above objects.


(h) To help & render relief to poor in all possible ways.

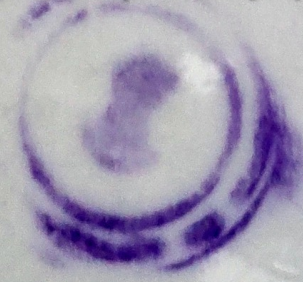

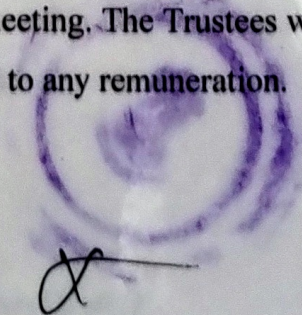
(6) **Filling of vacancies of Trustees :-** The vacancies of the trustee shall be filled up by other trustees by majority.

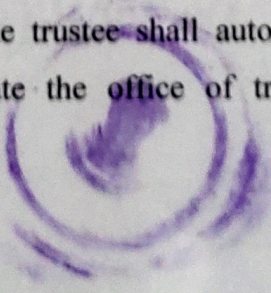

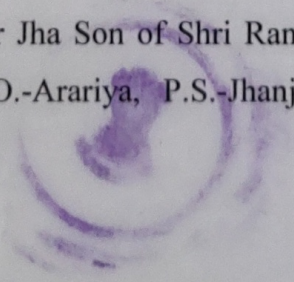

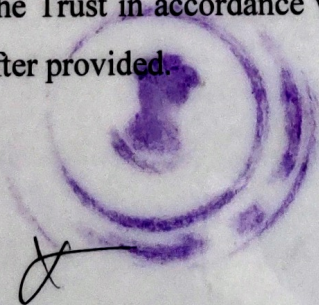
